Project Registration Fee*	\$20.00 per person field day (per project, no partial days) \$85.00 minimum
Digital Curation Fee	\$30.00 per gigabyte (TIFF only, JPEG not accepted).
Paper site records submission	\$10.00 per site card for site cards submitted in paper format
* The Project Registration Fee MUST be paid whenever your AAA permit is required to do the work OR you obtain an ASM site number. This fee is not assessed for projects subject to a collections curation fee (i.e., projects done under a repository agreement). In cases where limited collections must be made during non-collection survey or non-site monitoring, projects will be assessed BOTH Survey Project Registration and Collections Curation Fees.

Additional Maps or Maps in addition to shape files	\$15/map
Expedited Record Search (moves your request to the top, below other expedited requests)	\$250.00
Special Research Queries. 'Data Dumps' upon AZSITE Board Approval Only	Minimum \$200 setup fee. Contact the AZSITE Database Administrator for special search request options and to determine fees.
Scanning/Photocopying**	See "2013 ArcRecordsRates" document
*If you have not been approved for access to AZSITE, you will receive a map, which includes only ASM records and photocopies of ASM site records, if requested. You will then be required to contact other land managing agencies for similar records checks of their records to complete the record search process. These additional record searches are subject to individual land manager data access and fee policies.	
**Note: AZSITE Users: Site Cards and PRFs are online via the AZSITE website. If not, we will scan and put them there at no additional charge. If you want us to compile the documents, or we have to print anything and send it to you, it is 50 cents a page. Cultural Resource data, site cards, PRFs and reports, are distributed ONLY via the AZSITE Secured FTP site and are password protected.
